# F. LIBRARIAN'S REPORT

- a. M. Sullivan spoke on the following:
  - i. The library has been very busy as the summer started. Waiting to see statistics for June. Hoping to see an increase in active cardmembers, circulation. New adult programming added for the summer.
  - Friends of SLPL group is active and successful in their activities dine to donate, evenings with friends featuring guest speakers - a few events have maxed out in attendance.
    Craig Thatcher concert scheduled for September in new St. John shared facility.
  - iii. Friends of SLPL donated \$5,000 last week. Friends are in charge of the book sale room which becomes another donation to the library.
  - iv. Helping Hands campaign exceeded last year by \$1,000 to date
  - v. Summer Fun program runs June 19-August 7. Lots of raffle prizes available based on reading minutes, kids activities, attending programs.
  - vi. Melissa has 49 programs scheduled. Many already on wait list.

# G. OLD BUSINESS

- a. Fundraising
  - i. Red Robin Dine to Donate raised over \$250
  - ii. T-Shirts and tote bags selling slowly. Still have enough in each size.

iii. S. Arnold raised a question about how to let the community know that digital lending is available at the library. M. Sullivan spends 12% per year on materials. He allocates that money as needed each year. This year, M. Sullivan increased the Hoopla budget to \$1200. The most popular rentals are EAudio books. In addition to raising the budget, M. Sullivan purchased the most popular EAudio books for about \$1,000.

# H. NEW BUSINESS/DIRECTION/DISCUSSION ITEM

- a. P. Leonard sent out Bylaws in April for review. The Solicitor and the Board of Supervisors have accepted it. S. Arnold and K. Parsons raised a concern about Board of Directors membership liability. The municipality has the discretion to remove any board member at any time without cause. (Page 4). After discussion, the board felt that it is the prerogative of the municipal governing body to make changes to boards that they appoint. M. Sullivan stated that even though the Municipality can remove a board member without cause, they know they probably should have cause. The majority of the board wanted to keep the language as is instead of going back to the Solicitor and Board of Supervisors who will most likely not make any changes.
