## F. LIBRARIAN'S REPORT

- a. M. Sullivan spoke on the following:
  - i. In addition to a new hard drive, the library replaced the printer at the front desk. Both under warranty.
  - ii. Deiter Bros fixed a leak in the HVAC serving story hour side of the meeting room. Deiter Bros also fixed the thermostats. They also looked at a drip in the ceiling, which is condensation from the AC unit.
  - iii. Marie Miller, one of "founding mothers" of the library, passed away. The family made the library a beneficiary of a memorial gift.
  - iv. To date, 368 kids, 41 teens, 146 adults registered for the raffles where you earn tickets by reading, doing activities and attending library programs. All summer library programs are filled.
  - v. M. Sullivan has been more generous with the programming budget this year than in the past. Up to \$12,000 for both kids and adults throughout the year. Using the "Rainy Day Fund" to help with excess. There will be savings in other areas, so total spending will likely be the same. The plan is to keep a certain amount of money in the "Rainy Day Fund" for possible capital improvements. There is no plan for capital improvements at this time.
  - vi. Luke the accountant is taking the lead in getting quotes from auditors. Looking for three

- guotes from Buckno Lisicky, MVA and Fry & Co.
- vii. Upper Saucon approved the request to allow alcohol at up to two adult programs per year.
